What Information Does The App Collect?

The App does not collect any identifying information or contact information from you.

This information does not identify you personally but could include your age, grade level, gender, and city or state. You are not required to provide this information and may use the App without sharing it.

The app will automatically collect anonymous information about how you use the App, including information about the educational and career choices you select within the App.

Does Junior Achievement Share This Information With Anyone Else?

Junior Achievement will share with PricewaterhouseCoopers LLP ("PwC") what it learns from information you provide and information automatically collected by the App. Junior Achievement and PwC will use the information to understand how many people use the App and how they use it to learn.

Can I Share My Progress On Social Media?

You may share updates about your progress through the curriculum to social media platforms by using the social media buttons within the App. The App does not collect your user name or password or gather any information from your social media profile. You should review the privacy policy of any social media platform before using it.

How Does The App Protect Address Children's Privacy?

The App is intended for people 13 years of age or older. The App is not designed for or intentionally directed to children younger than 13 years of age.
